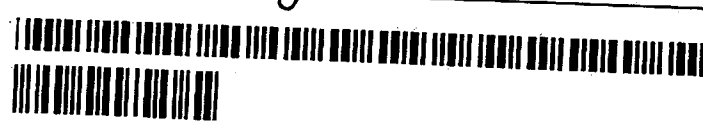

On 11/5/19, Detective J. Hicks was working for the Cape Coral Police Department Major Crimes Unit as a detective. Linda Sue La Roche (DOB: 10/10/1955) was arrested for an out of state fugitive warrant. The details of the investigation are as follows:

On 11/5/19, at approximately 1830 hours, Detective Hicks made contact with Linda La Roche at the Cape Coral Police Department. Detective Hicks ran Linda through CCPD Dispatch (NCIC/FCIC), who confirmed that Linda had a Temporary Felony Warrant for First Degree Intentional Homicide out of Racine County Sheriff's Office (Wisconsin). The warrant (#99-01) was active as of 11/5/19 and had full extradition.

Based on this, Linda was placed under arrest for the warrant and later transported to the Lee County Jail in apparent, good health.
