DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

On Thursday, December 2nd, 2021, Deputies responded to, 2475 10 Ave NE, Naples, FL (D4) to meet with a reporter reference information related to a male that had previously been reported missing by family on . The male, had, been reported missing from his residence at 10th Ave. NE. is physically handicapped due to multiple seizures, and pays the homeowner to live in the residence.

The reporter told deputies that she had information that may have been murdered at home and buried on the property by the home owner Michael Pritchard. The reporter would subsequently provide a taped sworn statement that he/she had been told by a friend that yesterday Pritchard had confessed to having shot because he caught masturbating into Pritchard's girlfriend's underwear. Pritchard told the friend that he then buried body next to the house.

I would subsequently speak to the friend who also provided a taped sworn statement that Pritchard confessed to him that he shot because he caught him masturbating into Pritchard's girlfriend's underwear. After shooting Pritchard told the friend that he buried next to Pritchard's house. Pritchard has a history of erratic and violent behavior. A search warrant would be issued for 10th Ave NE.

The search warrant was subsequently executed at Pritchard's home and curtilage at 10th Ave. NE. The body of was located on the property. The body had been recently buried in a shallow grave near the residence as described by the friend that Pritchard confessed to.

Pritchard was located on the property. Pritchard was subsequently placed under arrest, and transported to the Naples Jail Center for booking.
